General Terms and Conditions

1. **Services:** Client hereby engages Design Consultant to arrange and execute the purchase of the Materials (as described in Exhibit A) on Client's behalf set forth in the attached drawings numbered ____ thru ____ and signed and dated _____. Client takes full responsibility for approving this Purchase Agreement from which Design Consultant will execute the Order for the Materials.
2. **Delays:** Client understands the Delivery Date specified in this Agreement is approximate. Design Consultant shall not be liable to Client for any delivery delays caused by Client, Manufacturer, third parties or any other matters not within the control of Design Consultant.
3. **Cancellation/Changes:** Client understands that the products and materials described in Exhibit A are being specifically designed and custom built for Client and that Design Consultant and Manufacturer will take immediate steps upon receipt of this Purchase Agreement to acquire the Materials on behalf of client. Therefore this Agreement is NOT subject to cancellation by Client. This Agreement, may be subject to limited Changes, in the sole discretion of Design Consultant, provided Client shall be fully responsibility for any increased costs or delays caused by such Changes. All Changes shall be in writing and signed by Client and Design Consultant.
4. **Material Disclaimers:** (A) Stained Wood Finishes: Natural wood varies in color, and mineral streaks (and knots if applicable to wood selection) may be visible where parts of the tree absorbed minerals differently in one specific area than another. This phenomenon will affect the wood grain and texture and can cause stains to absorb inconsistently. These natural variations will be present in all cabinetry. (B) Painted Finishes: Natural expansion and contraction of solid hardwoods can be expected. As the wood moves depending on the humidity and temperature levels of the environment, the movement of the wood can at times become visible at joints on doors, drawers and frame members. This movement becomes more visible on painted finishes and will be present in all cabinetry. (C) Glazed Finishes: Are painted finishes that have been top coated with a contrasting stain to enhance their appearance and are subject to the same conditions as painted finishes. Glazed finishes are done by hand and are considered an artistic effect subject to slight variations which will be present in all cabinetry.
5. **Delivery of Materials:** Client agrees to accept delivery of the Materials when ready. The risk of loss, as to the damage or destruction, shall be solely Client's upon the delivery to the Delivery Address provided in the Basic Terms. Client understands that ALL deliveries of Materials are tailgate and that Client and/or Client's representatives shall be responsible for moving the Materials onto the Project site. In the event Client cannot accept delivery, it will be Client's responsibility to arrange for a suitable storage location for the Materials. It is the responsibility of the Client or Client's representative to unwrap and inspect all cabinets within 5 days from the time of delivery, either to the jobsite or into storage, for concealed damage. Failure to do so shall constitute an irrevocable acceptance of the goods and void any future claim from the Design Consultant or Manufacturer. Should Design Consultant have to reschedule delivery of the Materials for any reason including, but not limited to, Client's inability to accept the materials or a default by Client under Section 11 hereof, any and all additional expenses associated with the re-delivery of the Materials shall be the sole responsibility of Client.
6. **Storage of Materials:** Whether delivered into storage or at Clients residence, Client is responsible for providing humidity (between 25%-55% relative humidity) and temperature (between 60 – 90 F) controlled environment. Failure to do so can cause wood to expand and/or contract resulting in damage to the cabinetry and shall be the sole responsibility of the client or client's representatives to make repairs.
7. **Installation:** Client agrees that Design Consultant is not providing any general contracting or installation services under this agreement other than Project Management as it relates to the cabinet installation process and therefore, Design Consultant shall not be responsible for any damages or defects that may occur to the Materials supplied under this agreement. In addition, the Design Consultant shall not be responsible for any oversights, errors or omissions made by the Client's representatives (contractors, electricians, plumbers, etc.). Any and all parts necessary to rectify contracting and/or installation errors or damages will not be the responsibility of the Design Consultant. Notwithstanding, the foregoing, Client may order such parts through Design Consultant in a written Change order to this Purchase Agreement executed by Client and Design Consultant.

8. **Title:** Title to the Materials purchased under this Agreement shall not pass to Client until the full payment of Purchase Price to Design Consultant and Manufacturer.
9. **Warranties:** The Design Consultant warrants the cabinetry for defects in original materials or workmanship for a period of one year from date of delivery. Said Warranty covers the cost of materials for that period. After one year from the date of delivery the standard form of warranty shall apply to the service and equipment furnished in accordance with the manufacturer's warranty program.
10. **Exculpation:** Design Consultant's liability to client under this agreement shall in all cases be limited to the fees paid hereunder, notwithstanding anything in this Agreement to the contrary, no assets of any member of Design Consultant shall be subject to levy, execution, or other judicial process for the satisfaction of Client's claims hereunder.
11. **Client Default:** If, for any reason, Client (i) fails to make cash payment required by the Agreement in full on or before its due date or (ii) otherwise violates any of the Client's obligations under this Agreement, then Design Consultant may, at the option of Design Consultant, (a) terminate this Agreement, (b) cancel the orders executed pursuant to this Purchase Agreement, and/or (c) refuse to schedule or cancel delivery of the Materials hereunder. Upon termination, the Design Consultant shall be entitled to recover a sum equal to all amounts due and owing under this Agreement as if design consultant fully performed the Services hereunder, and Design Consultant shall be released from all obligations hereunder.
12. **Disputes:** Any dispute or controversy relating to this Agreement or the performance of the Services shall be determined by arbitration in the State of New York in accordance with the commercial arbitration rules of the American Arbitration Association then in effect, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The prevailing party to such action shall be entitled to recover from the other party all costs and expenses incurred in connection therewith, including but not limited to arbitration fees, collection costs, and reasonable attorney's fees.
13. **Default Interest:** Amounts due and unpaid under this Agreement shall bear interest from the date payment was due at 10% per annum.
14. **Agreement:** This Agreement embodies the entire agreement between Design Consultant and Client with respect to the subject matter hereof, and there have been and are no representations or agreements made other than those provided herein. This Agreement may only be amended, supplemented or modified by a written instrument executed by Client and Design Consultant. If any term, covenant or condition of this Agreement is held to be invalid, illegal or unenforceable in any respect, this Agreement shall be construed without such provision.
15. **Joint Liability:** In the event that there are two or more Clients, this Agreement will be jointly and severally binding on each of them.
